The GSE Composite Index dropped 86.93 points this week to 2,342.62 index-points (Year-to-date: -4.14%).

Investor confidence in the market is still low, which influences investor behavior and results in less actions at the bid's column on the market. With only one advancer and five (5) additional decliners during the week under review, the Ghana Stock Index continued to fall in the red.

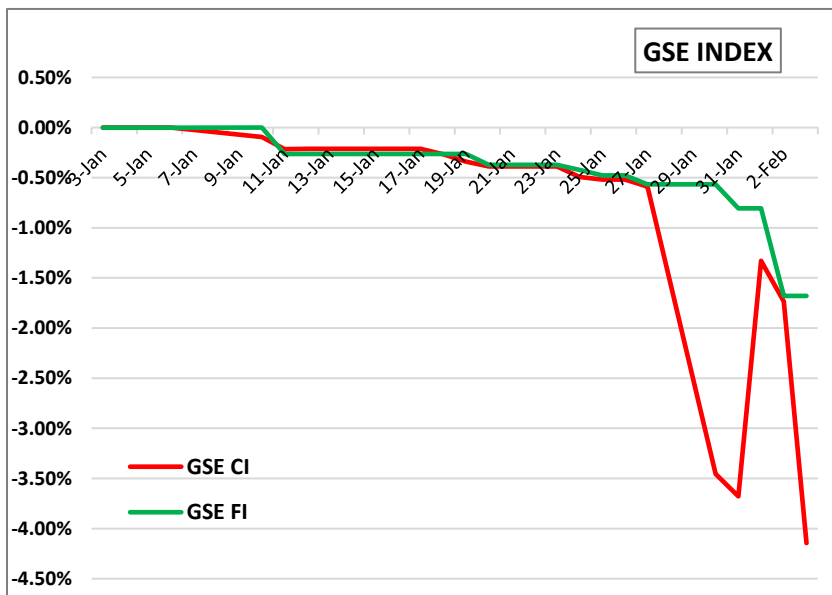
(TOTAL: +1.50%) was the lone advancer. (SCB: -1.04%), (MTNGH: -6.82%), (FML: -16.67%), (GCB: -10.91%) and (UNIL -42.01%) were the decliners for the week.







The GSE Composite index as a result slumped 86.93 points, bringing its index-point to 2,342.62 (YTD: -4.14%).

The Financial Stock Index also cut 22.84 points to 2,018.12 index points with a year-to-date change of -1.68%.

By close of week, a total volume of 902,475 shares valued at GHS827,475 were exchanged in twenty-one (21) stocks.

The market capitalization of the Ghana Stock Market is GHS 63,604.41 million.
